Description: The United Nations Development Corporation (UNDC), a public benefit

corporation of the State of New York, is seeking a qualified contractor to remove and dispose of the existing walk-in box and furnish and install a new walk-in box with a new refrigeration unit and associated work at Two UN Plaza. Two UN Plaza is a 40-story commercial office building and hotel located in east midtown Manhattan. The office portion of the building is

managed by Cushman & Wakefield.

The minimum required qualifications are as follows:

- A minimum of ten (10) years of experience in this field.
- Licensed by the State and City of New York.
- Liability insurance of \$10,000,000.
- A resume of current assignments at comparable Class A office buildings in New York City.
