of New York, is seeking a qualified vendor to provide IT consulting services and furnish and install new computer and phone equipment for the property management office at One UN Plaza. The scope of work includes, but is not limited to, coordinating with a contractor, furnishing and installing new computers, IP phones, and an IP phone system, and providing ongoing service and cloud storage for the computer and phone systems.

#### The minimum required qualifications are as follows:

- A minimum of ten (10) years of demonstrated experience in this field.
- Authorized to do business in the State of New York.
- Liability insurance of \$5,000,000.
- A resume of current assignments in New York City.

Interested companies must provide evidence of their qualifications and relevant experience including a minimum of five (5) references with contact information. The due date for submission of qualifications as a single PDF file via email is April 14th, 2025 at 12:00pm EST. #### **Procurement Lobbying Restrictions**
