Description: The United Nations Development Corporation (UNDC), a public benefit

corporation of the State of New York, is seeking a qualified contractor to furnish and install LED lights at portions of One, Two, and Three UN Plaza. The buildings are Class A high-rise commercial office buildings located in east midtown Manhattan. The buildings will be occupied and operational throughout the duration of the project. The UNDC properties are managed by Cushman & Wakefield. The general contractor's work

will include all equipment, materials and labor to:

- Remove old bulbs, fixtures and/or ballasts
- Furnish and install new bulbs, fixtures and/or ballasts
- Dispose of all materials

The minimum required qualifications are as follows:

- A minimum of ten (10) years of experience in this field.
- Licensed by the State and City of New York.
- Liability insurance of \$5,000,000.
- A resume of current assignments in New York City at comparable Class A office buildings.

Interested companies must provide evidence of their qualifications and relevant experience including a minimum of five (5) references from high-rise commercial office buildings in New York City with contact information.
