Description:	The United Nations Development Corporation (UNDC), a public benefit corporation of the State of New York, is seeking a qualified contractor to provide all material, labor, and oversight for the removal and replacement of four (4) existing Automatic Transfer Switches (ATSs) and associated mechanical and carpentry work at Two UN Plaza. The contractor must demonstrate the ability to direct and control multiple subcontractors to carry out their work simultaneously. Two UN Plaza is a 40-story commercial office building and hotel located in east midtown Manhattan. The building will be occupied and operational throughout the duration of the project. The UNDC properties are managed by Cushman & Wakefield.
	The minimum required qualifications are as follows:
	 A minimum of ten (10) years of demonstrated experience in this field. Licensed by the State of New York. Liability insurance of \$5,000,000. A resume of current assignments at comparable Class A office buildings in New York City.
	Interested companies must provide evidence of their qualifications and relevant experience including a minimum of five (5) references from Class A office buildings in NYC with contact information. The due date for

submission of qualifications via e-mail, regular mail, courier or personal delivery is April 9, 2024 at 2:00 pm EST. Please provide the name, telephone number, and e-mail address for a specific point of contact for purposes of this procurement. Companies determined to be qualified will be contacted and provided with a bid package and the date and time of a mandatory onsite pre-bid meeting. MWBE / SDVOB Participation Requirements

Pursuant to New York State Executive Law Article 15-A and Veterans' Services Law Article 3, UNDC is required to promote opportunities for participation by New York State-certified minority and women-owned business enterprises (MWBEs) and service-disabled veteran-owned businesses (SDVOBs) in the performance of its contracts. The MWBE goal for this contract is 30%, and the SDVOB goal is 6%. If the contractor is not an MWBE or SDVOB, they should consider utilizing MWBEs and SDVOBs as subcontractors and suppliers.
