### **MWBE / SDVOB Participation Requirements**

Pursuant to New York State Executive Law Article 15-A and Parts 140-145 of Title 5 of the New York Codes, Rules, and Regulations, UNDC is required to promote opportunities for the maximum feasible participation of New York State-certified minority and women-owned business enterprises (MWBEs) in the performance of UNDC contracts, and pursuant to New York State Veterans' Services Law Article 3 and 9 NYCRR 252, UNDC is required to make good faith efforts to maximize contractual opportunities for New York State-certified service-disabled veteran-owned businesses (SDVOBs). The MWBE goal for this contract is 30%, and the SDVOB goal is 6%. If the contractor is not an MWBE or SDVOB, they should consider utilizing MWBEs and SDVOBs as subcontractors and suppliers.
